1. Recap - what's NEC4?

- □ NEC4 was published in June 2017
- □ NEC3 was first published in 2005
- NEC branded it evolution not revolution
- New features & forms of contract
- ☐ Greater consistency across the family
- ☐ Clarified & simplified in response to industry feedback



2. ECC & PSC main Options



ECC main Options A & B

- Uses a revised Short Schedule of Cost Components for CEs
- Defined Cost of people uses tendered people rates
- ☐ Defined Cost of Subcontractors based on Subcontract cost
- ☐ Percentages for people & design overheads have been removed
- Defined Cost of manufacture & fabrication & design outside Working
 Areas based on tendered rates

ECC main Options A & B

- ☐ One *fee percentage* applied to all Defined Cost (11.2(10))
- ☐ Defined Cost includes the cost of preparing quotations for CEs
- New provision for Contractor to correct Activity Schedule so that it relates to Scope (55.1)
- New provision for incentivising Contractor to propose value engineering of Scope (16):
 - value engineering percentage, standard is 50% unless changed in Contract Data (63.12)

ECC main Options C, D & E

- Uses a revised (full) Schedule of Cost Components
- ☐ Removed option to use Short Schedule for CEs
- Defined Cost of people visiting Working Areas clarified
- Further clarifications to people component to ensure payments are related to work on the contract & are in accordance with a persons employment contract
- □ Payments in relation to people for meeting the law tightened only covers contributions, levies & taxes

ECC main Options C, D & E

- Percentage for Working Areas overheads removed
- ☐ Defined Cost of manufacture & fabrication & design outside Working Areas based on tendered rates
- New provision allowing Contractor to finalise parts of Defined Cost (50.9)
- Activity Schedule is no longer revised if Contractor changes a planned method of working

PSC main Options A, C & E

■ Most radical of all changes made to NEC3 contracts
 □ All main Options use Defined Cost instead of Time Charge
 □ Option A uses Short Schedule of Cost Components for CEs
 □ Assessments based on tendered People Rates & Subcontractor cost + Fee
 □ Options C & E use Schedule of Cost Components for payment & CEs
 □ Assessments based on people costs + % for support people and office overhead, & Subcontractor costs + Fee

NEC3 PSC main Option G

- Option G removed from NEC4: no call-off Option PSC
- ☐ Could use Term Service Contract (amended) or the Framework Contract (limited to 4-years in UK / EU)
- ☐ Some clients are adding it back via Z clauses



3. ECC dispute resolution & secondary Options



ECC dispute resolution

- □ Now called "resolving & avoiding disputes" emphasis on avoidance
- ☐ W1 & W2 include referral to *Senior Representatives* named in Contract Data
- Mandatory prior to adjudication in W1
- Used by agreement in W2 to comply with HGCRA 1996
- W1 prevents Parties referring same or substantially the same dispute to adjudication in an attempt to achieve a different outcome (W1.3)

ECC dispute resolution

- New Option W3 for a Dispute Avoidance Board (DAB)
- ☐ Can only be used when HGCRA 1996 does <u>not</u> apply, i.e. cannot be used for most construction work in UK
- Straightforward amendments to give right to go to adjudication at any time could make it compliant
- Consists of 1 or 3 members, 3rd member jointly chosen
- □ DAB visits site regularly (stated in Contract Data)

ECC secondary Options

□ Option X1 (inflation) – provisional indices not corrected
 □ Option X2 (changes in law) – PM cannot notify this as a CE
 □ Option X4 (ultimate holding co.) – replaces parent co. guarantee
 □ Option X8 (undertakings to Others) – from PSC, instead of warranties
 □ Option X9 (transfer of rights) – from PSC, was common NEC3 Z clause
 □ Option X10 (information modelling) – amended version of NEC BIM clauses

ECC secondary Options

Option X11 (termination by Client) – moved from core clauses to align with PSC
 Option X15 (Contactor's design) – includes for professional indemnity insurance, document retention & use of material
 Option X16 (retention) – provides for a bond in lieu of cash retentions
 Option X21 (whole life cost) – Contractor proposals for reducing operational costs
 Option X22 (early contractor involvement) – incorporates clauses published by NEC in 2016

4. General & Contractor's main responsibilities



General

- Can specify an electronic communication system e.g. Fast Draft in the Scope to help improve contract compliance and control (13.2)
- ☐ Flexibility to have different *periods of reply* for different types of communication (13.3)
- Risk Register replaced with Early Warning Register & risk reduction meetings replaced with early warning meetings (15)



General

- Project Manager responsible for preparing first Early Warning Register & requires regular early warning meetings (15.2)
- Contractor not to commit Corrupt Acts, to takes action to stop a Corrupt Act of a Subcontractor or supplier & to include equivalent provisions in subcontracts & supply contracts (18)



Contractor's main responsibilities

- Contractor includes in subcontracts rights equivalent to those in the contract for the Client to use the Subcontractor's design (22)
- □ Contractors encouraged to subcontract on either unamended NEC terms or terms amended in accordance with the *conditions of contract* (26.3)
- Assignment & disclosure clauses added as these type of clauses were commonly added by industry as Z clauses (28 & 29)

5. Programme & time



Programme

- NEC3 only dealt with the contents of the programme
- NEC4 deals with the form also, e.g. a Gantt chart produced in a particular software format (31.2)
- □ **Deemed acceptance** of a programme submitted for acceptance (31.3)
- □ Requirements for a reminder from the Contractor then one week later deemed acceptance if no response from PM (31.3)

Time

- ☐ If PM instructs Contractor to stop or not start work, then may instruct removal from Scope or to re-start or start work (34.1)
- Acceleration PM's instruction to provide quotation only comes after PM & Contractor have **agreed** to consider the proposed change (36)



6. Quality & Defects



Quality

- New requirements for Contractor to:
 - operate a quality management system (requirements stated in the Scope) &
 - submit a quality policy statement & plan for acceptance
- NEC3 PSC approach applied to ECC (40)



Defects

- ☐ Supervisor issues Defects Certificate at the *defects date* if there are no notified Defects or the **earlier** of:
 - end of the last defect correction period &
 - date when all notified Defects have been corrected (44)
- Allows Defects Certificate to be issued earlier than in NEC3



7. Payment



Applications for payment

- Contractor obliged to submit an application for payment **before** not on each assessment date (50.2)
- \square Form of the application is to be stated in the Scope (50.2)
- □ Potentially heavy sanction for non submission of application (50.4)
- ☐ Likely that nothing will be paid
- Removes NEC3 obligation for PM to assess amount due without an application

Final account

- ☐ Final account procedures introduced (53)
- PM assesses & certifies no later than:
 - 4 weeks after Defects Certificate or
 - 13 weeks after termination certificate
- ☐ If PM does not assess, Contractor may issue assessment to Client
- ☐ If Client **agrees**, final payment is made within 2 weeks (or other period in Contract Data as for other payments
- Assessment is conclusive evidence of final amount due unless disputed

8. Compensation events



Compensation events

- PM notifies Contractor that quotation for a proposed instruction is not accepted – allows the Contractor to be reimbursed for cost & time spent producing quotations (60.1(20))
- Additional CEs can be stated in Contract Data part one for specific project risks this was in NEC2 but removed from NEC3 (60.1(21))
- ☐ CEs can now be notified up until the Defects Certificate is issued, previously it was up until the *defects date* (61.7)

Compensation events

- New concept of a dividing date to clarify the switch date between actual & forecast Defined Cost for CE quotations
- ☐ Widely debated issue with NEC3 which (hopefully) NEC4 now resolves
- CEs arising from instructions, notifications, certificates or changed decisions – dividing date is date of that communication
- ☐ For other CEs dividing date is date of the notification of the CE (63.1)

Compensation events

- □ Clarified which Accepted Programme to use for CE quotations it's the one current at the dividing date (63.5)
- New clause 65 brings together all the provisions for proposed instructions



Summary – how to avoid nasty surprises?

- ☐ Ensure the Clients, Project Managers & Supervisors are **up to date with NEC4** before procurement commences
- Educate your staff & supply chain help them to understand the changes
- Understand how the changes affect your tender evaluation models & ensure they align with NEC4
